Three County Bar Associations Are Recipients of Pennsylvania Bar Foundation Grants

The Pennsylvania Bar Foundation launched the Birdsall Impact Grant Program in March 2008, with the intention of awarding grants totaling no more than \$1,000 annually over the next 10 years to assist county bar associations in implementing a program or project, or enhancement of an existing program or project, that succeeded in making an immediate impact on the way county bar associations operate in service to their members, the courts and their community.

Open to all bar associations, with consideration given to those with limited needs, the program drew seven exemplary applicants in the inaugural year.

A committee comprised of five Foundation Life Fellows, three of whom were appointed by then-Foundation President Karen Balaban and two of whom were named by Conference of County Bar Leaders President Michele Dawson, thoroughly reviewed each application.

The committee concluded that the first awards be presented to the Butler County Bar Association to support lowcost CLE for attorneys participating in the association's pro bono and modest means lawyer referral programs and to the Lawrence County Bar Association to support the purchase of a laptop computer to provide access to PBI group casting CLE programs for members of the bar.

The awards were presented to Lawrence County Bar Association Executive Director Joellen Pastore and to Marion Laffey-Ferry, accepting on behalf of the Butler County Bar, at the Foundation's annual meeting on June 5 in Hershey.

In addition, the Cumberland County and Butler County Bar Associations have taken advantage of a matching grant program conducted by the Pennsylvania Bar Foundation to assist county bar associations in launching modest means lawyer referral programs.

In the first year of a two-year commitment, the Foundation will provide a maximum of 10 matching grants of \$250 each to county bar associations that establish modest means lawyer referral programs following the guidelines promulgated by the Pennsylvania Bar Association's Task Force on the Legal Needs of Middle Income People. The one-time grants are awarded on a first-come, first-served basis.

PBA President McClain Promotes County Bar Outreach

As "the first sole practitioner in modern history" to serve as PBA president, C. Dale McClain's goals for the upcoming bar year include promoting county bar outreach, encouraging pro bono for children through the PBA Child Advocate Pro Bono Committee and continuing to develop the PBA legislative grassroots system. The incoming president outlined these plans during his June 6 address to the PBA House of Delegates in Hershey.

Calling for PBA members and county bar associations to work together to advance the goals of the profession, McClain announced that the PBA would focus on coordinating its programs, committee and section activities, and member benefits with county bar associations.

He explained that serving for eight years on the executive committee and a year as president of the Conference of County Bar Leaders showed him the benefits of joint efforts by the PBA and county bar leaders.

He reminded those attending that the Pa. Bar Insurance Fund and Trust offers grants to county bar associations to purchase video equipment for use in their bar association buildings, saying that installing the equipment would allow for PBA and PBI programs to be conducted in several locations at the same time, thus reducing members' time out of the office, travel time and costs of transportation and lodging.

"When members are asked why they are not more active in the PBA's committees and sections or do not attend their meetings or programs, many say they cannot take the time to travel to these meetings," he said. "For many of our members, the travel time exceeds the time actually spent at the meeting. The PBA must make it easier for our members to get the full benefit of membership by participating in the activities of our committees and sections."

McClain said he also intends to strengthen and expand the PBA grass-roots legislative effort.

"This past year showed us that when we have a crisis — like the proposed sales tax on legal services — that affects everyone's law practice, we can get the members to respond to their legislators," he said. "The PBA achieved a result that shows your PBA membership is a very good investment in the success of your professional practice."

To promote this effort, McClain has asked the PBA Board of Governors to work with local bar officers and leaders and PBA committee and section members.

The goal is for the PBA to continue to develop its grassroots contact system, with at least two personal contacts for every one of Pennsylvania's 253 legislators. To promote this effort, McClain has asked the PBA Board of Governors to work with local bar officers and leaders and PBA committee and section members.

PBA Joins County Bars in Fall Public Education Campaign

"How a Lawyer Can Help You" is the topic for the October 2008 statewide public education campaign, which is a joint effort of the Pennsylvania Bar Association and county bar associations.

This year, the PBA's Community and Public Relations Committee is charged with overseeing the statewide lawyer image campaign as well as rolling out the statewide legal public education print campaign, which is offered every other year and is free-of-charge to local bar associations that choose to participate. The public education print campaign includes newspaper ads about a selected legal topic and the mailing of free informative brochures to the public.

The committee surveyed local bar associations about the direction of the campaign in 2008. Local bar associations that returned the survey indicated they wanted the PBA to use its existing commercials (showing how lawyers help the public with starting a business, and with elder law problems) and would like the commercials to run in tandem with the statewide print public education campaign in the month of October. The campaign topic favored by most local bar associations for the campaign was "How a Lawyer Can Help You."

County bar associations were asked for a contribution of \$4 per PBA member in their county bar association to fund the electronic media portion of the campaign. County bar associations can participate free of charge in the print advertisement portion of the campaign.


