Bar Leaders Honored at 37th Annual CCBL Seminar

Three awards were presented Feb. 28 during the 37th Annual Conference of County Bar Leaders (CCBL) Seminar, which was held at the Hershey Lodge and Convention Center. Richard "Dick" E. Flannery received the Gilbert Nurick Award; Louis N. Teti received the Chief Justice John P. Flaherty Award; and Bucks County Bar Association Executive Director Patricia M. Martin received the Arthur J. Birdsall Award.

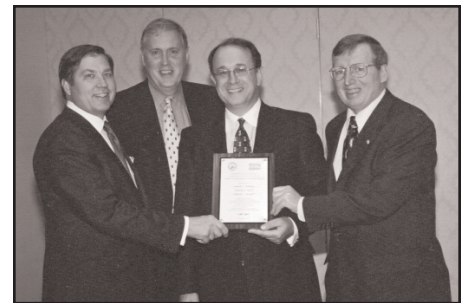
The Gilbert Nurick Award, which is named for the late Harrisburg lawyer and PBA president, is presented to a PBA member who exhibits dedication and service to the leadership and promotion of the organized bar and its activities. Although the award is not intended to be annual, it has been presented every year since it was given to Gilbert Nurick in 1991.

In his written nomination of Richard E. Flannery, Lawrence County Bar Association (LCBA) President Joseph V. Bullano noted, "Dick is an extremely competent and well-qualified attorney who shows dedication and enthusiasm for the Lawrence County Bar Association, the Pennsylvania Bar Association and the legal profession as a whole. ... The Lawrence County Bar Association and the legal community have benefited greatly from Dick's continued and unwavering dedication and leadership over the years."

As a young lawyer, Flannery helped develop lectures to present in Lawrence County high schools; these lectures have become part of LCBA's Law Day program. He initiated a number of organizational changes when he was LCBA president, including amending the bylaws (for the first time since the 1960s), revamping the committee system, hiring an executive director, bringing the *Lawrence Law Journal* in-house and obtaining an office for the LCBA in the Lawrence County Government Center at no cost to the association.

Flannery is a member of the PBA House of Delegates and the LCBA Law Journal and Legislature Committees. He is vice chair of the PBA Judicial Evaluation Commission, co-chair of the LCBA Building Committee and a trustee of the LCBA executive com-

mittee. A former member of the PBA Board of Governors, Flannery also has served as LCBA secretary.

The Chief Justice John P. Flaherty Award, named for the former chief justice of the Supreme Court of Pennsylvania, is presented to an individual who has been active in the CCBL and has worked to improve the legal profession, the justice system or the community.

Louis N. Teti, recipient of the Chief Justice John P. Flaherty Award, has been involved with the ABA, the PBA and county bars for many years. He has worked as a program originator, moderator and panelist for the CCBL. He has chaired the PBA Client and

Community Relations Committee, which began a campaign of community outreach programs in partnership with local bars. Teti served nine years in the ABA House of Delegates and is a past president of the PBA, the Chester County Bar Association and the Chester County Bar Foundation.

When he served as PBA president and vice president, he visited over 50 county bar associations. Teti also initiated "Quality of Life" programs that were presented across the state. He is co-chair of the PBA Law-Related Education Committee, a member of the PBA Representation Task Force and a trustee of the PBA Insurance Fund and Trust.

The Arthur J. Birdsall Award, which is named for the PBA county bar services director who has served the PBA for more than 30 years, is pre-

sented to a county bar executive who demonstrates the highest traditions of professional excellence, is committed to the success of his or her bar association and has enhanced significantly the stature of his or her bar association. Birdsall accepted the first award at the 32nd Annual CCBL.

Patricia M. Martin, the Arthur J. Birdsall Award recipient, has served the Bucks County Bar Association for 16 years; prior to that, she worked with the St. Petersburg, Fla., bar association for nine years. She was on the CCBL executive committee from 1994 to 1995. Martin has made numerous improvements to the Bucks County Bar Association and has continuously supported the bar association staff.

"Pat has motivated, encouraged and 'insisted' on bar member participation," wrote Delaware County Bar Association Executive Director Eliza-

County Bar Associations Play Important Role as Pennsylvania Celebrates Law Day 2003

There's still time for county bar associations to get free Law Day materials and join the PBA in celebrating its fourth annual Law Day this May with the theme "One Nation Indivisible."

The events of Sept. 11, 2001, left a lasting impact on all Americans, including children. As Americans continue to come together as a result of those events, there is a unique opportunity — and responsibility — to teach children about the country's strength and history. Words like *freedom*, *democracy* and *equality* can become prevalent in the classroom as members of the bar work with schools and parents to foster the spirit of America in children.

Lawyers and judges are being encouraged to visit their local schools and to use the PBA's new, free law-

related lesson plan guide during classroom visits. Many local bar associations already have plans underway for their annual Law Day festivities. The PBA Law Day program and materials are designed to enhance and supplement existing efforts. Similar to last year, interested county bar associations can request free lesson plan guides to distribute to members and schools.

Law Day offers an opportunity to reach out to bar association members, not only by including them in Law Day activities, but also by helping them to reach out into communities. For county bar associations that would like to participate, but do not have a staff, the PBA can provide Law Day assistance.

The PBA also has created a new Law Day area on its Web site for

schools to visit for Law Day information located at www.pabar.org/lawdayinformation.shtml. The Web site features a schedule of county bar association Law Day activities; a list of all schools, lawyers and judges interested in classroom visits; and general Law Day information.

County bar associations are encouraged to forward to the PBA any information about their county's upcoming Law Day programs for publicity on the site.

Family Law CLE Seminar

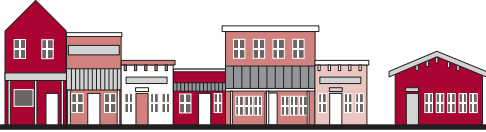

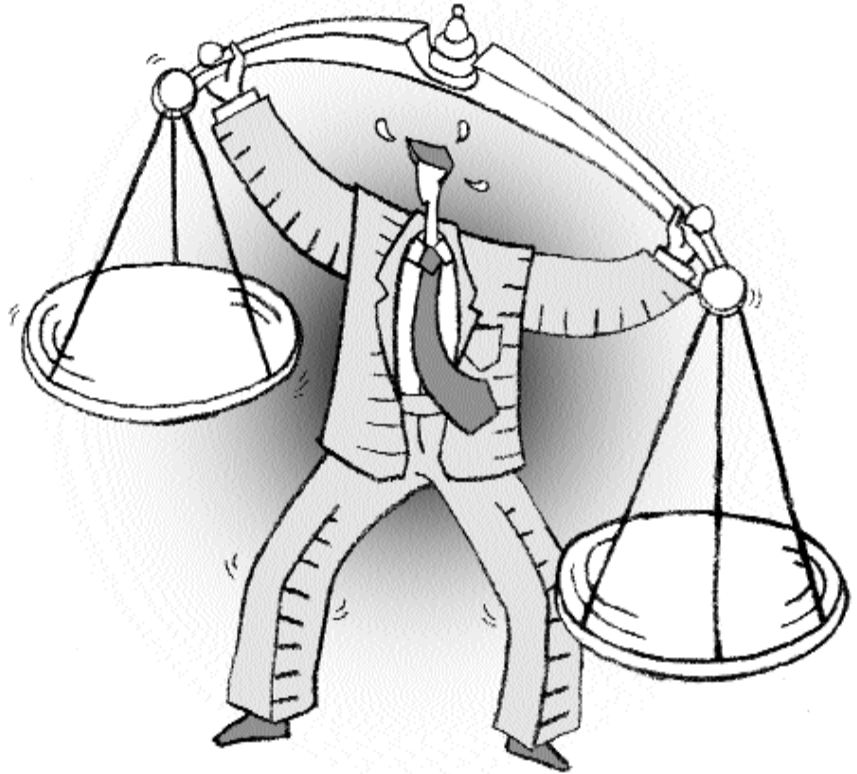

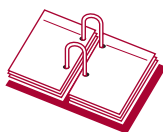
