# **Applications Wanted for Project PEACE Training**

The Pennsylvania Bar Association/ Foundation and Attorney General Mike Fisher are accepting applications for the fifth annual Project PEACE training conference to be held March 12-13, 2004, in Altoona.

All schools, regardless of socioeconomic status, diversity and location, have been forced by outbreaks of school violence to confront how conflict is handled in our society. Schools have sought to find ways to deter violence and bring about peace in the hearts and minds of students.

Project PEACE works to reduce violence in Pennsylvania's elementary schools by teaching students how to positively confront conflict and handle disagreements peacefully. It empowers younger children with important lifeskills that promote constructive communication, problem-solving, criticalthinking and self-esteem. Children become active participants in promoting positive behavior in their classrooms and beyond by taking on the role of mediator and using the mediation process. With the help of neutral peer mediators, conflicts can be settled in a positive manner, benefiting the school climate as a whole.

During Project PEACE training, school teams — composed of one administrator, one educator, one guidance counselor or a second educator, one parent and one attorney — are introduced to the peer mediation process through hands-on learning activities. They receive instruction in such areas as adjudication vs. mediation, diffusing conflict situations and the skills of conflict resolution. At the end of the training, schools write their own mediation plans, which are implemented in their local schools. The schools select and train their student mediators, and the student mediators then begin helping fellow students resolve disputes peacefully.

The Project PEACE training model was developed by the Temple University Beasley School of Law's LEAP Program. Project PEACE has been implemented in Indiana since 1994 under the auspices of that state's bar association and attorney general. Project PEACE is celebrating its fifth year in Pennsylvania.

# **Project PEACE Frequently Asked Questions**

Who Can Apply? All public, private & parochial elementary schools may apply.

**How Many Schools Will Be Selected?** Twelve elementary schools will be selected to attend the training conference — one school from each of the bar association's geographic zones.

Who Attends the Training? A school team must be composed of the following five individuals: one school administrator; one educator; one guidance counselor or a second educator; one parent; and one local attorney.

When & Where is the Training? The Project PEACE training conference will be held March 12-13, 2004, at the Ramada Inn, Altoona, Pa.

**What Costs are Involved?** All costs associated with meals, lodging and training materials will be covered by the PBA and the Office of Attorney General. Selected schools will only be responsible for travel costs to and from Altoona.

When & How Will Schools be Notified of Acceptance? All application materials are due no later than Nov. 1, 2003. The selection committee then will review the applications and notify all schools in writing whether or not they have been accepted by Dec. 1, 2003.

#### **Slave Court Book Restoration**

The Delaware County Bar Association has recently completed the restoration of a record of court cases that dates to Colonial times. The Slave Court book, written with quill pens, recorded a time when slaves were not permitted to be tried in the same court as free persons. The period comprises an ugly chapter in American history, but it is seen as a valuable piece of history worth preserving and a vital link in doing justice to Delaware County's past. The Slave Court book had been missing for centuries, but in 1941 came into the possession of lawyer Alexander Geary, who returned it to the county.

"The plan is to put the book in a portable display case so it can be taken to various libraries and schools throughout the county and put on display and an explanation given by one of our members as to just what it represents," said attorney O. Warren Higgins, chairman of the bar's historical records committee.

#### **Bench Bar Conference**

Members of the Delaware County Bar Association recently gathered for a threeday Bench Bar conference, designed to provide education and to improve the working relationship between members of the bench and of the bar. At the conference, the DCBA presented the following awards: the Donald J. The Bar and Community foundations provided \$1,000 in scholarships to qualifying non-profit organizations to facilitate their participation in the event.

Funds raised at the recent the Wilkes-Barre Law and Library Association/ Luzerne County Bar summer outing and golf tournament were donated to the Luzerne County Victims Resource Center.
