Unmet Legal Needs

Clients in civil legal aid represent the diversity that is North Penn Legal Services' 20counties — encompassing all races, ethnic groups and ages, ranging from veterans to urban low-wage workers and the elderly.

Our attorneys and paralegals handle more than 9,000 cases each year, helping people in Northeast Pennsylvania living at or below the poverty level. For a family of four that means existing on \$25,000 a year.

In 2005, we closed 9,100 cases providing timely advice and brief service to 56% of our clients. We provided representation in 3,470 court and administrative hearings.

North Penn Legal Services is a private not-for-profit organization dedicated to providing free legal aid services on civil cases to lowincome families, individuals, and groups and equal access to justice for all in Northeastern Pennsylvania. in quantifiable benefits to help low-income clients meet basic needs.



Unfortunately, NPLS is currently meeting only 4.6 % of the legal needs of low-income people in Northeastern PA.

Most low- and moderateincome people feel shut out from the legal system. They do not turn to the courts for solutions because they believe the system will not help them. Civil legal aid ensures justice for all Americans, regardless of their income. Many people would otherwise not be able to afford access to the courts to resolve their legal troubles.

NPLS Remembers Attorney Joe Galletti

From the Desk of the D.A. By Susquehanna County District Attorney Jason Legg

Joe was an attorney—a good attorney. You might say that a good attorney is an oxymoron, but, if you do, then you did not know Joe. When I say 'good' attorney, I refer not only to his skills in this legal profession, but in the manner in which he conducted himself as a gentleman at all times.

In my view, you cannot be a good attorney in the absence of good character. Joe received his law degree in the State of Florida, and practiced law in Key West for several decades. After retiring in Florida, he wanted to live in the Endless Mountains—trading in the sun and the surf for a cabin in the mountains (and the snow).

When he moved to this location, he resumed the practice of law with North Penn Legal Services. As a result, Joe found himself thrust into a myriad of tasks representing those without the financial means to legally protect their interests.

Joe did not have the luxury of selecting his clients—or even the types of that he would handle. In this regard, Joe's 'retirement' was unlike the typical senior attorney who remains active but carefully selects the clients and types of cases in which he wants to get involved.

Joe was in the legal 'trenches'-and I

believe that is exactly where he wanted to be. All too often, the general public judges attorneys by the style of their suit, the model of their car, or the size of their home. Success is measured with dollar signs the bigger the bankroll, the greater the success, and the better the attorney.

For this reason, there is a tendency in the public to assume that a legal aid attorney or a public defender is less of an attorney than one hired privately. This assumption is not only erroneous— but it is disrespectful to hose attorneys that commit themselves to public service.

This is not to say that there are not private attorneys who are more skilled than public defenders; but the converse applies, there are public defenders that are more skilled than private attorneys.

You should not judge a book by its cover—or the clothes he wears or the car she drives. While success may certainly result in the acquisition of material wealth, the measure of a man's character requires consideration of more than a man's finances.

Joe was a family man—a loving husband and a terrific father. On his casket, there was a framed copy of the song 'Amazing Grace', and we were told that Joe had placed it in a prominent location in his home so that he saw it every morning when he got up. This small, framed object sitting upon the large coffin was a tremendous sign of faith and thanks-giving.

Silently, it spoke loudly of the character of a good man. Joe may not have selected his clients, but he represented them with skill and ardor. I know because I fought against Joe in some of those legal 'trenches'.

While I believe that some of his clients did not truly appreciate him, Joe never failed to represent each client effectively and fairly. In many ways, Joe not only represented these disadvantaged folks—but he gave them a gift. At a time in their lives when there appeared to be no hope, when the entirety of a powerful legal system was closing in upon them, Joe strode forth to take their hand and help them through a difficult legal process.

His clients did not always make his job easy—but he always did it well. Through his counsel, Joe was able to give them hope—and, in such dire circumstances, hope is a precious gift.

Joe earned my respect and admiration over the few years that I knew him, and the legal community here in Susquehanna County has lost a good attorney, and our community in general has lost a good man. For those of us who knew Joe, we were blessed, and I am sure that God's Blessings will be poured upon Joe and his family in this difficult time.

Goodbye Joe.

Governor Rendell Expands Heating Assistance

More Pennsylvania families will be able to stay warm this winter as Governor Edward G. Rendell announced an expansion in eligibility for Pennsylvania's Low-Income Home Energy Assistance Program (LIHEAP), which opened on Nov. 6. At the Governor's direction, income eligibility for the 2006-07 LIHEAP season was expanded from 135 percent to 150 percent of the Federal Poverty Income Guidelines.

Applications for LIHEAP are available at County Assistance Offices, local utility companies and community service agencies, such as Area Agencies on Aging or Community Action Agencies. Families can also apply for LIHEAP cash grants online at

Employment Law Project Begins

The new Employment Law Project provides assistance to individuals in a variety of cases that arise from the employment context. Garry Wamser, Managing Attorney at our Bloomsburg Office will be directing the Employment Law Project.

Where possible, we provide advice, referral, and/or assistance in the following cases:

- language discrimination
- job preservation cases (FMLA, etc.)
- barriers to employment (criminal record expungement, occupational license problems, unfounded abuse allegations, etc.)

- wage cases (failure to issue last paycheck, FLSA, etc.)
- drivers' license appeals if crucial to employment
- consultation on at-will employment, severance, and covenantnot-compete questions

We are developing an outreach plan designed to train other NPLS staff on how to identify some of these Employment Law issues, and how to screen these issues. As a result, local offices will handle a greater variety of Employment Law issues, as opposed to just unemployment compensation.

SUCCESS STORIES...Justice for the Elderly and Mentally III

Marie is 70 years old. Divorced after 40 years, she owned her house and car free and clear, both in good condition. She survived on Social Security of \$550 per month.

An unscrupulous car dealer convinced her to trade in her car on a new/used car with payments of \$498 a month—well beyond Marie's financial abilities. When Marie showed the car to a friend he convinced her to call that same night and beg for the return of her car. The dealer assured her he would make it right, but the next day refused to return her car and sold her another car with half the monthly payment. Marie experienced a mechanical breakdown with the vehicle and the car was repossessed.

Marie arrived at our Bloomsburg

Office stating that she was contacted by a collector for \$5,000 still owed on the repossessed car. An NPLS attorney sued the car dealer for Unfair and Deceptive Practices. On the eve of the trial they settled, paying off the repossessed car debt and paying Marie \$2,000 toward a new car.



John lived with his parents on a farm that had been in the family for generations. He has for a number of years suffered from depression, anxiety, with some psychotic features. He was, however, able to maintain a grounds keeping job at a cemetery. The local government decided to confiscate the farm through eminent domain in order to build a school. The legal battle was prolonged and bitter.

After the family was forced to move off the land, John slid into a severe depression. Despite being hospitalized and practically catatonic, John was denied disability at the initial level, probably due to lack of medical evidence. Our attorneys in the Scranton Office were able to gather the necessary evidence to show at the appellate hearing that John was unable to maintain a job. He was able to receive assistance to live and medical benefits to continue treating his mental illnesses.
